I was raised on a small mixed farm south of Minburn and attended my primary education at the Mannville School.


Upon graduating high school I attended Lakeland College for my pre-University studies and then was accepted to the University of Alberta where I obtained my degree in Pharmacy in 2007.

/ CURRENT CHAIR, AUDIT & FINANCE COMMITTEE



/ CURRENT BOARD MEMBER


